## Morocco – Seminar on environmental and land rights banned

On 1 July 2016, a seminar on environmental and land rights scheduled to take place at the Municipal Council of Marrakech was banned by the Moroccan authorities. It was organised by **Attac Maroc**, the **Moroccan Association for Human Rights**, and **Amazigh Citizenship Network**.

<u>Attac Maroc</u> - Association pour la Taxation des Transactions pour l'Aide aux Citoyens Maroc (Association for the Taxation of financial Transactions and Aid to Citizens) is an international movement established in 1998 working on the protection of environmental and land rights, and engaged in creating social, environmental and democratic alternatives. The movement also works on the cancellation of the debt of developing countries, fair trade, and the implementation of limits to free trade. Attac was established in Morocco in 2000. In 2014 the organisation filed a complaint to the administrative court of Rabat after the authorities refused to renew its registration.

<u>The Moroccan Association for Human Rights</u> (Association Marocaine des Droits Humains – AMDH) works on promoting the culture of human rights through education and awareness-raising. It monitors human rights violations in Morocco and provides legal support for victims. It also works to ensure that Moroccan law complies with international human rights standards. The organisation reported that between July 2014 and May 2016, Moroccan authorities arbitrarily banned or disrupted 104 of its events, including conferences and sit-ins.

<u>Amazigh Citizenship Network - Azetta</u> (*Réseau Amazigh pour la Citoyenneté*), established in 2002, gathers more than a hundred associations working on the promotion of principles of tolerance and diversity through public awareness. The Network has been largely advocating for the advancement of Amazigh rights in Morocco, including the promotion of their cultural rights and documenting cases of discrimination against Amazigh people. It is also the first registered organisation to have included secularism as one of its main objectives.

On 1 July, as Morocco prepares to host the 7th annual Sustainable Innovation Forum at the 22nd Conference of the Parties to the UN Framework Convention on Climate Change (COP22), the authorities banned a seminar on environmental and land issues and challenges in Morocco, that was to be held at the Municipal Council of Marrakech. Attac Maroc – Marrakech Branch, AMDH – Mnara Branch, and Azetta – Marrakech Branch were informed by the authorities, upon their arrival to the venue, that the meeting could not convene, despite the fact that they had fulfilled all of the required conditions and administrative procedures for holding an event.

A peaceful protest was held shortly after the ban before the Municipal Council. It was followed by a discussion with <u>Imider movement</u>, also called Movement On The Road '96, about the deteriorating land conditions in the village of Imider, where silver mining company Managem has reportedly <u>damaged</u> the land, polluted the environment and reduced access to potable water. The mine, which is owned by the royal family, is reported to use a quantity of water twelve times higher than the daily consumption of all the local community inhabitants. Imider Movement reports that the authorities have systematically attempted to weaken them and arbitrarily arrested several activists with groundless accusations.

Front Line Defenders expresses its concern at the banning of the seminar, which forms part of a pattern emerged in the last two years of disrupting events organised by human rights defenders and organisations in Morocco.

## Front Line Defenders urges the authorities in Morocco to:

1. Guarantee in all circumstances that the right to freedom of association and peaceful assembly, in particular for human rights organisations, are fully respected;

2. Guarantee in all circumstances that all human rights defenders in Morocco are able to carry out their legitimate human rights activities without fear of reprisals and free of all restrictions.
